#### **Confirmation of the Minutes and Action Taken Report**

1. Confirmation of the minutes of the 3<sup>rd</sup> Sikkim State Higher Education Council meeting held on 18-2-2017.

2. Action Taken report on the 3<sup>rd</sup> meeting of the SSHEC held on 18-2-2017.

The Director HE, HRDD presented the Action Taken Report on the 3<sup>rd</sup> meeting of the SSHEC held on 18-2-17. Action Taken Report was noted.

### Matter for Consideration and Approval.

The Director HE, HRDD highlighted the Sikkim State Higher Education Plan 2018-2020 to the SSHEC:

- a. Component No 1: Creation of University by upgradation of existing Autonomous College.
- b. Component No 5: Creation of three Model Degree College at Mangshila, Khamdong and Chakung.
- c. Component No 6: Upgradation of Existing Degree College to a Model Degree College at Namchi, Rhenock and Burtuk.
- d. Component No 7: New Colleges (Professional) at Dentam.

- e. Component 9: Infrastructural grants to Colleges at all Existing colleges in Sikkim.
- f. Component 11: Equity Initiatives at all existing Colleges in Sikkim.
- g. Component 12: Faculty Recruitment Support for 45 faculty positions.

The council after discussing all the proposals placed in the meeting unanimously approved the plan for 2018-20.

#### Section 5: Other Issues discussed

- 1. NAAC-The house had an elaborate discussion on the status of NAAC accreditation with respect to the institute and its importance after roll out of RUSA 2.0.All the college heads present were advised to take up necessary steps to apply for NAAC accreditation. All requirements needed for the accreditation should be immediately addressed and the meeting decided to instruct all colleges to apply in the present cycle. Hon'ble Minister, HRDD directed the house to form a committee to look into the process and monitoring of NAAC related issues.
- 2. The Vice Chancellor Sikkim Manipal University informed the house on the main parameters for NAAC. He advised the colleges to give more focus on teaching-learning method, curriculum and Research/Publications by Faculty.
- 3. Vice chancellor Sikkim University suggested on colleges to also focus on NIRF (National Institute Ranking Framework). The house was advised to make the governing councils vibrant in their functioning and the department to take necessary action in this matter. The house was also informed on the NIRF Ranking of 198 achieved by Sikkim Government College, Tadong and the achievement was much appreciated by all.

The meeting ended with a vote of Thanks by the Joint Director, RUSA.
